EDUCATION - RELATED

- Tutoring

EMPLOYMENT - RELATED

- Work permits

- Other goods and services that will assist the youth in obtaining or maintaining employment

ESSENTIAL DOCUMENTS

- State ID
- Driver's license
- Birth certificate
- Passport

TRANSPORTATION

- Down payment assistance on an automobile (pre-approval required)
- Automobile tag, tax, title
- Automobile insurance
- Automobile repairs, maintenance
- AAA membership
- Transportation including bicycle, occasional Uber or Lyft, bus passes, occasional gas cards for work, school, family visitation

HOUSING*

- Application fees
- Rent deposit
- Rent payment
- Short-term room and board
- Utility deposit for gas, water, electric
- Utility payment for gas, water, electric
- Youth must be working towards selfsufficiency.

*Eligibility: Youth who were in DHS or tribal custody on their 18th birthday. May require a housing assessment.

DORM OR HOUSEHOLD ITEMS

- Moving expenses
- Furniture (does not include baby furniture or electronics)
- Appliances
- Dishes, silverware
- Pots, pans, cooking utensils
- Sheets, blankets, pillows, comforter
- Towels, washcloths
- Other items that will assist the youth in a successful transition to living in their own place.
